POLITICAL ACTION FUND

Because of the importance of legislation being acted upon in Albany, the Association has established a political action committee (PAC), called the Greater New York Automobile Dealers Association, Inc. Political Action Fund. The PAC is funded by members of the Association through a "check-off of \$350" which is already included in your membership dues.

This means that payment of your dues implies permission to designate \$350 to the PAC. If you choose **NOT** to be a member of the PAC, dues remain \$845 for primary dealerships and \$600 for secondary dealerships. You must sign and completely fill out the form below, directing us **NOT** to apply \$350 in your name to the PAC.
